



STATE POLICY PRIVATE PRACTICE

Clubs affiliated to the AKA are covered by the AKA's broad form liability insurance policy, subject to the terms and conditions in place:

The policy provides insurance protection to clubs that conduct official/ permitted kart race events that are conducted in accordance with the AKA rules and regulations and other approved events.

The aim of the AKA's liability policy is to provide protection for legitimate/official club/State/AKA activities that are conducted in accordance with established practices, rules and regulations.

To this end private practice at kart clubs affiliated with AKA Qld (inc) are authorized to conduct private practice with the knowledge and approval of the affiliated club's official authorities and in accordance with the details below.

Conditions for participants utilizing private practice at affiliated AKA Qld Inc club facilities are as follows:

- All users of the circuit must be / or have current and valid AKA licenses as outlined in Chapter 13 of the current AKA Manual.
- All users of the circuit must comply with the Protective clothing regulations as outlined in Chapter 14 of the current AKA Manual.
- All Karts must meet the basic Kart Formula as detailed in Chapter 25 of the current AKA Manual in order to participate in private practice.
- Track use restrictions as outlined in Chapter 13.20 are at all times applicable.
- There **MUST** be at least two (2) persons at the circuit at all times in order for private practice to be authorized to take place.
- All drivers must be familiar with the basic details of the Rules of the Road as outlined in Chapter 16 of the current AKA Manual.

- Club authorities are to maintain a practice log and ensure that all participants have completed the appropriate disclaimer form and are recorded in that log if participating in private practice.
- Any injuries sustained by participants in private practice are to be recorded in the club practice log book – any claim for injury is to be completed on the appropriate form and dispatched to Trans West Insurance brokers as detailed on the claim form.
- Clubs participating in providing private practice facilities and use are to ensure that all member licence holders and visiting license holders are familiar with these conditions and a suitable notice must be displayed to advise of this policy.
- **Private practice approval is granted to all AKA Qld Inc affiliated clubs upon the approval of this policy, unless withdrawn by order of the State Executive / Council, and clubs must ensure that details outlined in the dot points of this policy are at all times adhered to in order to facilitate the liability and personal accident policies of the AKA Inc for their licensed members.**

"This policy was presented to and approved by our insurers who added that it was taken as read that practice only took place at AKA approved circuits, and pit crew would have met the required waiver of insurance requirements."
