### Club Rules for Track Hire / Membership

- All participating persons shall be a financial member of a Karting Australia (KA) affiliated kart club.
- All participating persons shall hold a minimum KA **E Grade** License.
- All participating persons shall comply with the KA Cyber Safety Policy.
- All participating persons shall comply with the KA Drug & Alcohol Policy.
- The track is to be used for kart traffic only.
- All karts are to comply with the standards as specified in the current KA Manual.
- All protective equipment and clothing must be worn as specified in the current KA Manual.
- The fee of **\$10.00 per kart** is payable at the time the key is received and a corresponding ticket shall be retained and made available for viewing upon the request of a Townsville Kart Club member.
- The key must be returned immediately after your practice session.
- The facility entrance gates shall be locked at all times.
- The key holder shall be responsible for all persons he/she allows access into the facility.
- Spillage of any fluids or materials on the Asphalt surface is forbidden.
- Any damage to the facility is the responsibility of the key holder and should be reported immediately.
- No Junior or Senior drivers are allowed on the track at the same time.
- **Intimidation or Bullying** will not be tolerated, and will lead to disciplinary action.
- No Alcohol or Smoking allowed in pit area.
- No Naked flames allowed in pit area.
- Covered footwear shall be worn at all times in the pits area.
- Private vehicles are not allowed into the Parc Ferme or Out/In Grid areas.
- All members are responsible for the cleanliness of the Facility.
- Failure to abide by these rules or those of the KA could lead to disciplinary action.
- Membership is conditional in accordance with the Townsville Kart Club constitution.
